**INDIANA TAX CREDIT**

The State of Indiana offers a special tax credit to tax payers in return for their support. When you make a gift to Ball State, you can receive a tax credit for 50 percent of your gift up to a maximum of \$200 for joint returns and a maximum credit of \$100 on single tax returns. You must use Indiana State income tax form CC-40 to claim your credit. *Note – this information is not intended as legal or tax advice. Please consult your tax advisor.*
